Now this deed witnesses:

That in consideration of SIG Design & Technology appointing the contractor as one of its "accredited contractors", the contractor agrees to indemnify SIG Design & Technology against all liabilities, demands, proceedings, damages, costs (including legal fees) and expenses sustained, incurred or payable by SIG Design & Technology to the extent arising as a consequence of or in connection with any claim by any third party (including its successors and assigns) to the extent that the claim has arisen as a result of any act, omission, negligence or default of the contractor, its employees, agents and/or subcontractors in relation to services provided by the contractor to SIG Design & Technology and/or its customers. This indemnity shall apply notwithstanding that, at the date of a claim, the contractor may no longer be an "accredited contractor" of SIG Design & Technology.

The contractor further agrees to arrange and maintain the following insurances:

- a) Employers liability - a minimum cover per claim of five million pounds;
- b) Third parties liability (including in respect of all agents and/or subcontractors involved in providing services to SIG Design & Technology and/or its customers) - a minimum cover per claim of one million pounds;
- c) Any other insurance required to cover its liabilities under this deed.

A certificate of insurance must be supplied to SIG Design & Technology on an annual basis.

This deed shall be governed by English Law and the parties agree to submit to the exclusive jurisdiction of the English Courts.

RULES FOR TRADING MEMBERS

Design & Technology Accredited Contractor (DATAC)

1. Always maintain highest quality standard of operation in compliance with DATAC Quality Standards documents.
2. Compulsory training must be undertaken, as directed by SIG Design and Technology at their training facility. Under no circumstances should training be carried out on site.
3. Compulsory training must be undertaken for all new DATAC members and for new DATAC products. A schedule of training fees is available from the DATAC Co ordinator.
4. All activities to take foremost account of Health & Safety requirements. New members to provide a copy of Health and Safety Policy.
5. Minimum ratio of 30% of trained supervisors with current installer cards to be present on every site.
6. Reciprocal business is compulsory.
7. DATAC Contractor must indemnify workmanship to SIG Design and Technology.
8. DATAC Contractor must be financially sound (Infocheck), with a set of accounts provided annually.
9. DATAC Membership to be reviewed periodically. SIG Design and Technology reserves the right to cancel DATAC membership at our discession.
10. Involvement of all DATAC members in developing and promoting excellence in product quality, technology and workmanship.
11. DATAC members must comply with the DATAC rules and general regulations.
12. The collective DATAC trademark cannot be used by a non-member.
13. Insurance cover minimum cover for Public & Product Liability of £1m, Employers Liability £5m.
